EU-passenger rights, administrative proceedings et al.

Representation at all stages

PoA and EU-wide representation

- Power of Attorney in Germany can be given in simple writing and sent easily in advance by E-Mail (Scan).
- Upon agreement with you, we deposit our General Power of Attorney at the major „aviation courts“ in Germany, claims can be notified directly to us (advantages: we can meet the deadlines easier, no hefty translation costs and so on).
- EU-wide representation – momentarily we represent in Germany, Denmark, Sweden, Austria and Poland.

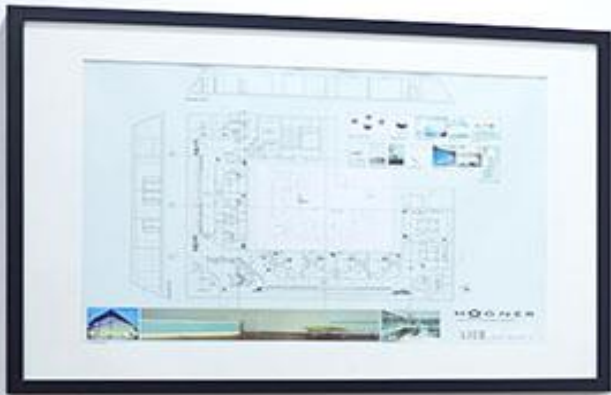
